### **SCHOLARSHIP**

### Detective Michael Davis, Jr. Memorial Scholarship Award

The California Homicide Investigators Association is proud to present the **Michael Davis Jr. Memorial Scholarship Award**.

On October 24, 2014, Detective Michael Davis, Jr. was shot and killed during a manhunt to arrest a carjacker who earlier had murdered Sacramento County Sheriff's Deputy Danny Oliver. Detective Davis had served with the Placer County Sheriff's Department for 15 years in Northern California and was about to celebrate his 43rd birthday. His prior service as a police officer was with the Auburn Police Department from 1996 to 1999. Detective Davis is survived by his wife, Jessica, and their four children.

Detective Davis was the 1<sup>st</sup> CHIA member killed in the line of duty. He would be honored to know that his legacy lives on and has a potential to help someone within the CHIA family. Detective Davis' father, Investigator Michael David Davis Sr., was killed in the line of duty on October 24th, 1988, while serving with the Riverside County Sheriff's Department. Their line of duty deaths occurred exactly 26 years apart to the day.

In 2018, CHIA presented the first two scholarships, \$2500 each, in his honor. The CHIA Scholarship Program was designed to provide funds to family member(s) of homicide victims in support of their education and/or job training efforts. Through these scholarships, the memory of Detective Michael Davis, Jr. will live on.



#### Cancellation

Exhibitors may cancel contracted booth space by submitting written notice/email to Lt Brian Kinney at <a href="VicePresident@chia187.com">VicePresident@chia187.com</a>. Such notice must be received no later than July 14, 2023. Exhibitors cancelling an exhibit booth shall be charged an administrative fee of 50% of the total cost of the space. Cancellation of contracted exhibit space between July 14 and August 15, will receive no refund unless CHIA can find a suitable replacement company. In the case a replacement company is found, the canceling company will only be charged that portion which has already been submitted for print (if any). If no suitable replacement is found, the company will be charged the full amount.

#### Restrictions

CHIA reserves the right to determine the eligibility of a company or their products/services for inclusion in the exhibitor's hall; and reserves the right to restrict exhibits that become objectionable to CHIA. No signs will be affixed by any means to the walls, doors or any other surface in the exhibit area. CHIA's policy restricts representation or organizations that have not been assigned an official exhibit booth from soliciting business and/or distributing promotional material of any type within the exhibit area. Further, those organizations that have been assigned an official CHIA exhibit booth should make every effort to conduct business activities within their assigned booth space and not to impede traffic through the exhibit aisles or other areas of the facility.
